1. Two sets of original Application to be filled (TO BE FILLED IN BLOCK LETTERS IN BLUE/BLACK INK ONLY)
2. Please enclosed all relevant documents substantiating your claim as a person of Indian origin (also see 10 & 11 in the application)
3. Attach 4 recent identical passport size(4cm x 4cm) photographs (Front pose with white background only)
4. Appropriate PIO card fee (Php 16700 for adult; Php8400 for children below the age of 18 year) should be deposited along with the application. The fee should be in cash only.
5. Enclose old Indian passport and photocopy of first two pages & last two pages or copy of cancelled Indian passport and Filipino passport in original, Photocopy of birth certificate in case applicants under 18 years along with PIO Card application.
6. Photocopies of both parent's passports are required in case applicant never held Indian nationality. In case of requirement the original passports requested should be produces.
7. NBI Clearance
8. The processing time for PIO Card application is 2 weeks in case of Philippine passports and 3 weeks in case other passports.
9. NOTE: Furnishing of false information will result in summary rejection of the application. Acceptance of application does not confer any right on the application to the PIO Card.
