GENERAL REQUIREMENTS

- Furnish photocopies of I-CARD by other nationalities who are permanent/long term residents in the Philippines
- Present passport with photocopy valid al least for 6 months
- Attach return ticket or airline computer print-out with ticket numbers
- Please provide photocopies of all original documents.
- Please staple the requirements properly

PLEASE READ

- Validity of the visa starts from the date of issued unless specifically endorsed, the visa is not valid for restricted or protected areas
- Extension of tourist visa is not allowed. Changed of purpose of visit is nor permitted.

- Contract of Employment with photocopy
- Sponsorship letter from India
- Guarantee letter from the local Company
- TOURIST VISA (For Filipino nationals only)**

BUSINESS VISA

- Invitation letter from India
- Original sponsorship letter or employment certificate from the Local Company
- Proof of financial standing and expertise in the field of intended business
- Foreign nationals with less than two years residence in the Philippines must apply in the countries of their origin/ citizenship

LONG TERM VISA (1-5 years)For

Persons of Indian origin:

- Copy of previous Indian Passport or Indian passport of his/her parent(s) in case applicant has never held an Indian passport
- Filipino married to Indian national:
 - Marriage Certificate
 - Indian Passport (Spouse's name should be included in the Indian national's passport)
- Filipino one of whose parents is Indian national:
 - Birth Certificate
 - Indian Passport (Spouse's name should be included in the Indian national's passport)

STUDENT VISA

- Admission letter from the recognized Educational Institution in India
- Satisfactory evidence of Financial Support
- Passport of sufficient validity to cover period of studies

TRANSIT VISA TO OTHERS

- Passport valid up to 6 months
- Confirmed ticket for onward journey

EMPLOYMENT

- Contract of Employment (original with photocopy)
- Letter from the employer justifying the appointment of a foreigner
- Documentary proof of educational qualification and professional expertise
- Proof of Registration of the Company under relevant provisions of the Government of India rules
- Interview by the Consul
- Foreign nationals with less than two years residence in the Philippines must apply in the countries of their origin/ citizenship.
